The undersigned, individually and on behalf of all parties acting on her behalf (together, the "Participant"), hereby releases, indemnifies and holds harmless American All-Star, LLC, the National Football League and, the New Orleans Louisiana Saints, LLC, and each of their respective agents, employees, officers, directors, owners, partners, members, and all parties for whom they may be responsible, and if applicable, owners and lessors of premises used for the event, affiliates of any of the above-named entities or their affiliates, and sponsors, promoters and all other persons or entities associated with the Halftime Show, from (including, without limitation, liability for personal injury, death, and property damages) which may be suffered or which may arise or which may be in any way connected with the Halftime Show.

The Participant understands that the rehearsals & performances involve a significant degree of physical activity. The Participant certifies that she is in good physical health and condition and is free from injury or disability which might impair her ability to participate without limitation in the dance class, rehearsal or performance during the 2018 NFL season.

The Participant certifies that all information provided by the Participant on this enrollment form is true, correct and complete in all material respects. The Participant hereby authorizes American All-Star, LLC to investigate and confirm with third parties the correctness of any information provided by the Participant.

The Participant hereby consents to the use of her likeness, name and voice by American All-Star, LLC, and the New Orleans Louisiana Saints and the Saintsations in connection with their informational, promotional and marketing web based data and audio recordings or on the American All-Star or Saintsations web site, without compensation to the Participant.

I hereby confirm that I have read and have voluntarily signed this Release and Consent in consideration of the right for my child to participate in the 2018 Halftime Performance, and that I fully understand its provisions.

1- During all activities, no alcoholic or non-prescription drugs are allowed in your possession.

2- During all activities, you are not allowed to associate with anyone in an unsuitable manner, to be determined at the sole discretion of Saintsations/American All-Star Staff members.

3- During all activities, no smoking is allowed under any circumstances.

4- During all activities, you will not be allowed to leave any scheduled practice or activity without the expressed permission from an official Saintsation/American All-Star Staff members.

5- During all activities, you will, at all times, follow the direction of designated Saintsation/American All-Star Staff members

6- During all activities, any violation of the Rules and Regulations, as well as rules and regulations (whether oral or written) of Saintsation/American All-Star and/or agency or business associated with American All-Star (including, without limitation, class or rehearsal sites), will result in immediate dismissal from the Halftime Performance. Inasmuch, American All-Star has the sole discretion in determining if the performer should be removed from the group and returned home. If it is determined that the performer be removed from the group, the costs (membership fee, etc.) will not be refunded and the performer must turn in her costume and will not be allowed to participate in any other activities or events. The below signed parent/guardian agrees to indemnify and hold harmless American All-Star in the implementation of these rules.

7- The performer's parents or guardians, as attested by the signatures below, assume complete financial responsibility for any and all damages resulting from the negligent and/or willful acts of their son/daughter(s).

I further agree to indemnify, defend, and hold harmless Releasees from damages arising from my participation or association with activities and events organized or sponsored by Releasees.
